UCP PROHIBITED SUBSTANCE ABUSE POLICY REMINDER

UCP of Sacramento and Northern California has a zero tolerance drug and alcohol policy and is dedicated to providing a safe, healthy, and productive work environment for all team members and to our clients.



UCP recognizes that the illegal and excessive use of prohibited drugs and/or alcohol are not conducive to safe working conditions. Therefore, the use, sale, purchase, transfer or possession of any prohibited substances and/or alcohol by any team members while on duty and/or on UCP's premises is strictly prohibited.

If UCP has reasonable suspicion to believe that a team member is intoxicated or under the influence of prohibited drugs and/or alcohol, then that team member may be directed to undergo an immediate reasonable suspicion drug and/or alcohol test. This test will be tested for the presence of Amphetamines (Methamphetamine), Marijuana, Cocaine, Opiates (Morphine), Phencyclidine (PCP) and/or alcohol (ethanol) in one's system.
